
ADOPTED ON JAN 25 1993

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF TWO HOURS, effective between the hours of 8:00 a.m. and 6:00 p.m., Saturdays, Sundays and certain holidays excepted, be and the same is hereby established for the following areas in the Ocean Beach Business Improvement District: Santa Monica Avenue (both sides) from Cable to Abbott Streets; Niagara Avenue (both sides) from Sunset Cliffs Boulevard to the western terminus of Niagara Avenue; Abbott Street (east side) and Bacon Street (both sides) from Santa Monica to Newport Avenues; Sunset Cliffs Boulevard (west side) from just north of Santa Monica Avenue to just south of Niagara Avenue.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized

to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
