BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,130,800 from San Diego Facilities and Equipment Leasing Corporation Construction Fund 91101, CIP 21-834.0, is hereby authorized, solely and exclusively to provide funds for the above agreement, each succeeding authorization to supplement previous authorizations, to be expended in the following manner:

\$771,000 from the Balboa Park/Mission Bay Park Certificates of Participation Phase IA;

\$154,200 from the Balboa Park/Mission Bay Park Certificates of Participation Phase IB, contingent upon issuance of said COPs; and

\$205,600 from the Balboa Park/Mission Bay Park Certificates of Participation Phase IC, contingent upon issuance of said COPS. BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves upon advice of the administering department.
