BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, a fourth amendment to the agreement of September 15, 1986 with Architects Richard Bundy & David Thompson, for professional services regarding the Alvarado Filtration Plant – Joint Laboratory and Training Facility, under terms and conditions set forth in Amendment No. 4 on file in the office of the City Clerk as Document No. RR- $\frac{281386}{}$, as well as any further amendments or modifications thereto which do not increase project scope or cost which the City Manager shall deem necessary from time to time to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$30,000, consisting of \$18,000 from CIP 73-257.0, Water Revenue Fund 41500 and \$12,000 from CIP 46-123.0, Sewer Revenue Fund 41506, is hereby authorized, solely and exclusively for the purpose of providing funds for this project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
