BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with Chevron U.S.A., Inc., for removal and replacement of sewer mains on Harbor Drive, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-281387, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$117,187.18 from Sewer Revenue Fund 41506, CIP 44-001.0, Annual Allocation for Sewer Main Replacement, is hereby authorized, solely and exclusively to provide funds for this project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstance so warrant.
