

RESOLUTION NUMBER R-281389

ADOPTED ON JANUARY 25, 1993

WHEREAS, on January 28, 1991, the City approved a five (5) year agreement with Luth & Turley, Inc., contractors for responses to incidents involving property damage from City sewer and water main failures; and

WHEREAS, the renewal of the second option year is based upon the contractor's above standard performance during the past year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with LUTH & TURLEY, INC., for general reconstructive contracting and cleanup work for damages to private property as outlined in Council Policy (400-10) and for those property damages for which the City may be responsible, under the terms and conditions set forth in the Agreement beginning February 1, 1993 through January 31, 1994 on file in the office of the City Clerk, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$700,000, consisting of \$363,300 from the Water Utilities Water Fund 41500 and \$336,700 from Sewer Fund 41506, is


