BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with National University, for the provision of employee personal computer training services, as required for an initial contract period of February 1, 1993 through June 30, 1993, with three options to renew periods beginning July 1, 1993 and ending June 30, 1996, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR- 281390.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$80,187.50 from General Fund 100 (\$48,112.50) and Enterprise Fund (\$32,075), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
