BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$19,008 from Police Department Fund 100, Dept. 110, Org. 485, Object Account 4682, Job 111482, to cover costs for the period July 1, 1992, through June 30, 1993, is hereby authorized and approved.
