RESOLUTION NUMBER R-281406

ADOPTED ON FEB 01 1993

WHEREAS, a watershed is an area of land that drains into a common body of water; and

WHEREAS, much of San Diego drains through a system of storm drains and channels before emptying into San Diego Bay; and

WHEREAS, nonpoint sources of water pollution are those which each individual and business unwittingly contributes to runoff such as the excessive use of fertilizer and the improper disposal of automotive fluids; and

WHEREAS, nonpoint sources have become the largest contributor of pollution to our nation's waterways; and

WHEREAS, the City of San Diego is committed to the protection of the water quality in its watersheds and in San Diego Bay; and

WHEREAS, the City of San Diego, the Unified Port District, the State Water Resources Control Board and Environmental Health Coalition are working together to promote the protection of the San Diego Bay watershed through a citizen education program; and

WHEREAS, students and teachers of the San Diego Unified School District participated in a watershed protection education campaign and poster contest which will help educate the people of San Diego; and

WHEREAS, the winning watershed posters have been incorporated into a 1993 San Diego Bay Watershed Protection

Calendar for distribution to the people of San Diego; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that this Council, for and on behalf of the people of San Diego,
hereby proclaims the month of February 1993 to be "SAN DIEGO BAY
WATERSHED PROTECTION MONTH" and encourages all the people of San
Diego to do their part to prevent pollution in urban runoff.
