
RESOLUTION NUMBER R-281411

BE IT RESOLVED, by the Council of The City of San Diego, that the low bid of PAC WEST LAND CARE, INC., is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF THE DESIGNATED MEDIANS, RIGHTS-OF-WAY, LANDSCAPED SLOPES, AND EQUESTRIAN TRAIL WITHIN CARMEL VALLEY LANDSCAPE AND LIGHTING MAINTENANCE DISTRICT (CONTRACT AREA 7) as may be required for a period of one (1) year beginning February 1, 1993 through January 31, 1994, per prices on file in the Purchasing Department, for a total estimated cost of \$45,699.05; terms 2% 20 days, with options to renew contract for four (4) additional one (1) year periods with increases not to exceed 18% of the prices in effect in each prior period.
