
RESOLUTION NUMBER R-281417

FISHER, executed in favor of The City of San Diego, bearing date of June 17, 1992, a copy of which deed is on file in the office of the City Clerk as Document No. RR-281417, granting to said City an easement for a public alley in Lots 5 and 6, Block 25, Ocean Beach Park, Map No. 1167, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public alley.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
