
RESOLUTION NUMBER R- 281426

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$100,000 from Scripps/Miramar Special Park Fee Fund No. 11230 to CIP No. 29-801.0, Scripps High School Joint Use Athletic Lighting; and to transfer an amount not to exceed \$53,000 from Scripps/Miramar Special Park Fee Fund No. 11230 to CIP No. 29-729.0, Jerabek School Ballfield Renovation.
