WHEREAS, the City of National City entered into an agreement with The City of San Diego entitled "Sewage Disposal Agreement of 1960," dated November 17, 1961, which is on file in the office of the City Clerk as Document No. 168453; and

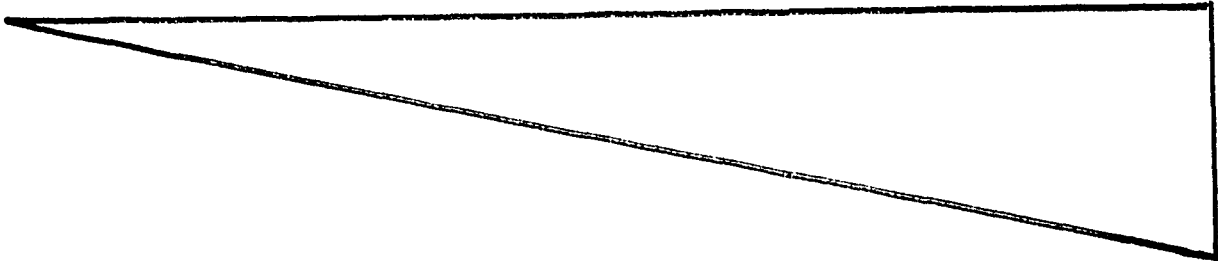
WHEREAS, Spring Valley Sanitation District entered into a "Supplement to the Sewage Disposal Agreement of 1960" with the City of San Diego, dated August 15, 1961, which is on file in the office of the City Clerk as Document No. 630490; and

WHEREAS, the Spring Valley Sanitation District, and The City of San Diego have executed the following amendments to the Agreement:

1. First Amendment - June 4, 1979 - Document No. RR-251701-2.

2. Second Amendment - January 9, 1984 - Document No. RR-259929-4.

3. Third Amendment - July 1, 1985 - Document No. RR-263754; and

WHEREAS, since the execution of the Sewage Disposal Agreement of 1960, the supplement, and the amendments thereto, the City of National City has entered into an Agreement with the Spring Valley Sanitation District, whereby the City of National City desires to transfer to the Spring Valley Sanitation District 1.00 million gallons per day of the capacity which it has leased from The City of San Diego, and the Spring Valley Sanitation District desires to assume the obligations for the payment of money in connection with the 1.00 million gallons per day capacity which will be transferred to it; and

WHEREAS, The City of San Diego has determined that the transfer will not unbalance the Metropolitan Sewerage System ("Metro System") to the detriment of the City or any other Participating or Later Participating Agency; NOW, THEREFORE,

BE IT RESOLVED, that the City Council of The City of San Diego hereby authorizes the City Manager to consent to an agreement between the City of National City and the Spring Valley Sanitation District for the transfer of 1.00 million gallons per day capacity in the Metro System.


BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized to enter into the Fourth Amendment to the Sewage Disposal Agreement with the Spring Valley Sanitation District.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized to enter into the Second Amendment to the Sewage Disposal Agreement with the City of National City.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized to enter into an agreement with the Spring Valley Sanitation District for the transportation of sewage through the Otay Mesa Transmission System.
