RESOLUTION NUMBER R- 281432

ADOPTED ON FEB 01 1993

WHEREAS, the Seal Rock area in La Jolla is the only known "haul-out" site used by harbor seals south of Point Mugu; and

WHEREAS, harbor seals are considered a depleted species by the California Department of Fish and Game; and

WHEREAS, the establishment of the Seal Rock area as a marine ecological reserve for a trial period would protect harbor seals and other marine mammals from disturbance by swimmers, boaters and divers; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager is authorized to post signs in the Seal Rock area outlining relevant Federal Code sections and San Diego Municipal Code section 63.02.10 and to provide interpretive signage in the area;

2. That the Council encourages the establishment of a non-City sponsored volunteer docent program for the Seal Rock Ecological Reserve;

3. That the Council invites non-City sources to fund and conduct a two-year seasonal scientific study, subject to scientific review, of the Seal Rock area.


