BE IT FURTHER RESOLVED, that the next low acceptable bid of PARKHOUSE TIRE INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing TIRES AND TUBES, Group II - Radial Police High Speed; Group III - Radial/Bias Tube and Tubeless, Light Trucks; and Group VI - Miscellaneous Fire Department Truck Tires, for a total annual estimated cost of \$197,994.00; terms net 30 days, plus sales tax.


