BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for REHABILITATION OF STORM DRAIN AT ADELPHI PLACE.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer of \$60,000.00 from CIP 17-001.0, ANNUAL ALLOCATION - MINOR DRAIN REQUIREMENTS, TransNet Fund 30300, to CIP 11-295.0, ADELPHI PLACE DRAIN; and authorizing the expenditure, not to exceed \$85,000.00, from CIP 11-295.0, ADELPHI PLACE DRAIN, \$25,000.00 from DIF Fund 79519, and \$60,000.00 from TransNet Fund 30300, for the purpose of executing this contract and related costs.



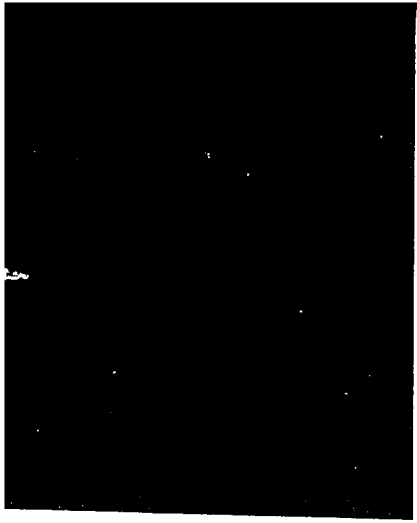
