BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to do by City Forces all the work necessary to monitor and perform adjustments to the water delivery system, to shut down and drain the pipeline, and to perform operational testing as required in connection with construction of Miramar Pipeline Rehabilitation - Phase I, pursuant to recommendation that said work can be done by City Forces more economically than if let by contract, with the cost of said work not to exceed \$390,000.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$390,000 from Water Revenue Fund 41500, CIP No. 70-910.2, Miramar Pipeline Improvements, is hereby authorized, solely and exclusively to perform the construction and related services by City Forces.
