
WHEREAS, the San Diego Public Library has been invited by the California State Library to apply for a Library Services and Construction Act (LSCA) grant to develop a Library Grandparents and Books Program; and

WHEREAS, the program would rely on trained senior volunteers to conduct programs for children, and would allow the Library to increase its outreach services and children's collection; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to apply for a grant in the amount of \$25,000 from the California State Library for the purpose of developing a Library Department Grandparents and Books Program.

BE IT FURTHER RESOLVED, that the City Manager or his duly designated representative is hereby authorized to perform all acts necessary to secure and administer funds received under the grant.
