
RESOLUTION NUMBER R- 281452

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$350,000 from CIP 29-795, Fund 38043, is hereby authorized, solely and exclusively for the purpose of acquiring property rights and related costs of four parcels for the Otay Valley Regional Park.


