WHEREAS, it is the goal of The City of San Diego to gain recognition as a cultural destination, and build the image of San Diego as a place rich in cultural assets; and

WHEREAS, the City authorized a curatorial examination of city-owned art by the San Diego Historical Society in January 1989; and

WHEREAS, 48 pieces of art with a combined value in excess of \$1,000,000 were reviewed and in August 1990, the study was concluded; and

WHEREAS, the San Diego Commission for Arts and Culture ("Commission"), San Diego Historical Site Board and San Diego Park and Recreation Board accepted the report of the Curatorial Examination of City-owned Art in October 1990 and recommended implementation of an in-depth examination and treatment of the artworks; and

WHEREAS, the City has allocated funds from the Public Art Fund pursuant to Ordinance No. 17667 (New Series) adopted July 23, 1991, and as amended by Ordinance No. 17782 (New Series) adopted June 1, 1992, to conduct a complete examination and restoration of selected City-owned artworks; and

WHEREAS, the San Diego Commission for Arts and Culture implemented the established procedures and guidelines (Administrative Regulation 25.70) for the selection and hiring of an art conservation firm whose work requires professional skills and the consultant was selected from an open and competitive process including a comparison of qualifications and output quality and each step in the process was objective, fully documented and in accordance with The City of San Diego's Minority ("MBE") and Women ("WBE") Business Enterprise Program; and

WHEREAS, the Commission advertised a Request for Proposals ("RFP") for an art conservation firm in the Daily Transcript and the Latino Newspaper for one week, mailed RFP's directly to ten (10) art conservation firms, screened four (4) proposals, and interviewed four (4) finalists; and

WHEREAS, Balboa Art Conservation Center met all of the selection criteria, including artistic excellence, extensive professional and diverse experience, timeline and budget constraints; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and directed to execute an Agreement with Balboa Art Conservation Center for an in-depth examination and treatment of selected City-owned artwork at a cost not to exceed forty thousand dollars (\$40,000).

BE IT FURTHER RESOLVED, that the expenditure not to exceed forty thousand dollars (\$40,000) from Public Art Fund (No. 10270), is hereby approved for the purpose of the above-described Agreement.
