BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby commends the Oak Park Community Council for their hard work and persistence in helping to ensure a quality of life for the residents of Oak Park.

BE IT FURTHER RESOLVED, that February 22, 1993 be and it is hereby proclaimed to be "OAK PARK COMMUNITY DAY" in San Diego.
