APPROVING MAP OF GLENCOE HEIGHTS.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Jorge H. Palacios, Registered Civil Engineer, entitled "GLENCOE HEIGHTS, Lot 826 of Lomita Village Unit No. 5, in the City of San Diego, County of San Diego, State of California, according to the map thereof No. 2998, filed in the office of the County Recorder, San Diego County, June 4, 1953, together with that portion of Lot 22 in Moody's South Addition to Lemon Grove, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 1290, filed in the Office of the County Recorder of said San Diego County on October 7, 1910, lying westerly of the westerly line of Grove Heights Unit No. 2, according to the map thereof No. 3473, filed in the Office of the Recorder of said San Diego County on July 25, 1956, and all that portion of the alley adjoining the property described above on the south as vacated and closed to public use on January 22, 1957 by Resolution No. 137373 of the City Council of The City of San Diego, a certified copy of which was recorded in the Office of the Recorder of said San Diego County, on January 28, 1957 in Book 6434, Page 172 of Official Records; the portion of existing public utility easement dedicated per Map No. 2998, lying within the boundary of this map, which was not shown, is vacated


pursuant to the provisions of Section 66499.20 1/2 of the State Subdivision Map Act," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Glencoe Drive, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a street is accepted on behalf of the public as heretofore stated; that those easements with the right of ingress and egress for the construction and maintenance of drainage facilities, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
