WHEREAS, the City Manager issued Report No. 93-30 on January 27, 1993 recommending a new procedure for developing recommendations to the City Council regarding the annual allocation of Transient Occupancy Tax funds for Civic Events and Promotional Programs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves a new procedure for the annual allocation of Transient Occupancy Tax funds for Civic Events and Promotional Programs to be implemented as follows:

For the Fiscal Year 1994 process, direct the City Manager to appoint a nine-member temporary board, with membership nominated by the City Council and Mayor, to be advisory to the City Council. A review of the temporary board structure and program to be made within a year's time, prior to establishing a permanent board.
