BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor be and he is hereby authorized to transfer \$5,000 from Fund 10223, Dept. 915, Org. 5019, Account 4222, to the Greater San Diego Chamber of Commerce for the purpose of allowing the Chamber to hire a consultant to help retain San Diego's military bases, and further, the Council encourages the consultant to stimulate the efforts of donors to require that there be matching funds from the private sector as well as using all available resources in the community.
