WHEREAS, the Regents Road Bridge Project (the "Project") is a project of The City of San Diego ("CITY") and is included in the City's Capital Improvement Program ("CIP") as CIP 53-044.0, and the North University City Financing Plan; and

WHEREAS, in order to award a contract to construct the Project, currently projected to occur in 1997, work must be begun on preparing all necessary environmental documents; and


WHEREAS, given the magnitude of the Project a consultant shall have to be hired to prepare the environmental documents; and

WHEREAS, in order to hire such a consultant, and begin preparation of the environmental documents, fifty thousand dollars (\$50,000) from CIP 53-044.0 for FY 1994 and fifty thousand dollars (\$50,000) from FY 1997 must be transferred to FY 1993; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby approves the transfer of funds from FBA Fund 79001

to CIP 53-044.0 FY 1993, as indicated above for the Regents Road
Bridge Project.
