BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Michael Brandman Associates, for the preparation of a project-level Environmental Impact Report regarding the Fiesta Island Replacement Project and the Northern Sludge Processing Facility, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$249,578 from the Clean Water Program Fund 41509, CIP Numbers 46-055.0, Fiesta Island Replacement Project, and 42-910.0, Northern Sludge Processing Facility, be and is hereby authorized, solely and exclusively to provide funds for this agreement, to be expended in the following manner:

- Phase 1 \$76,000 from CIP No. 46-055.0, Fiesta Island Replacement Project, and \$74,000 from CIP No. 42-910.0, Northern Sludge Processing Facility, Fiscal Year 1993 appropriations; and
- Phase 2 \$49,789 from CIP No. 46-055.0, Fiesta Island Replacement Project, and \$49,789 from CIP No. 42-910.0, Northern Sludge Processing Facility, Fiscal Year 1994 appropriations, contingent upon approval of the FY 1994 CIP budget.

BE IT FURTHER RESOLVED, that the City Manager is directed to authorize Funding Phase 1 as referenced in Section 4.1.2 et seq. of the agreement and, utilizing appropriate agreement provisions, not authorize Funding Phase 2 unless and until the contractor provides a full report on how it plans to comply with the City's MBE/WBE hiring goals.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
