
RESOLUTION NUMBER R- 281510

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute, for and on behalf of the City of San Diego, a one-year lease agreement (with four one-year extensions) with LEOTA SHAW, for the use by the Police Department of 750 square feet of office space at 5025 Newport Avenue for a Community Relations Office, at an initial rent of \$4,800 per year, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 281510 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$2,400 from Fund 100, Dept. 110, Org. 485, Account 4682, Job Order 111482, is hereby authorized to cover lease costs for the period January 1, 1993, through June 30, 1993.
