

- 2. That the expenditure of an amount not to exceed \$1.5 million from CIP No. 37-056.0, West Miramar Refuse Disposal Facility Phase II (Waste Management CIP Fund 41201), for the acquisition of real property and related costs, is hereby authorized and approved.
- 3. That the City Manager is hereby authorized to accept, for and on behalf of The City of San Diego, a grant deed of RANCHO DEL VISTA, LTD., a California limited partnership, or its successor in interest, to be subsequently executed on standard City form, conveying to the City 240 acres of vacant land in Boden Canyon as off-site mitigation for loss of sensitive habitat at the Miramar Landfill facility.
- 4. That the Auditor and Comptroller, upon advice from the administering department, is hereby authorized to transfer excess funds, if any, to the appropriate reserves.
