BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the transfer of \$1.5 million from CIP No. 37-250.0, Landfill Closure and Environmental Projects (Waste Management CIP Fund 41201), to CIP No. 37-056.0, West Miramar Refuse Disposal Facility Phase II, is hereby authorized and approved.

2. That the expenditure of an amount not to exceed \$1.5 million from CIP No. 37-056.0, West Miramar Refuse Disposal Facility Phase II (Waste Management CIP Fund 41201), for the acquisition of real property and related costs, is hereby authorized and approved.

3. That the City Manager is hereby authorized to accept, for and on behalf of The City of San Diego, a grant deed of RANCHO DEL VISTA, LTD., a California limited partnership, or its successor in interest, to be subsequently executed on standard City form, conveying to the City 240 acres of vacant land in Boden Canyon as off-site mitigation for loss of sensitive habitat at the Miramar Landfill facility.

4. That the Auditor and Comptroller, upon advice from the administering department, is hereby authorized to transfer excess funds, if any, to the appropriate reserves.
