RESOLUTION NUMBER R-281520

ADOPTED ON FEBRUARY 23, 1993

WHEREAS, on May 12, 1992, The City of San Diego submitted an application to the Planning Department for a Miramar Ranch North Community Plan amendment to reclassify Scripps Poway Parkway from a four-lane major street to a six-lane major street east from Spring Canyon Road to the community plan boundary; and

WHEREAS, the issue was set for a public hearing to be conducted by the Council of The City of San Diego; and

WHEREAS, the issue was heard by the Council on February 23, 1993; and

WHEREAS, the Council of The City of San Diego considered the issues discussed in Addendum No. 92-0399 to Supplemental Environmental Impact Report Nos. 87-1087 and 87-1088 concerning the road reclassification; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it is hereby certified that Addendum No. 92-0399 (as modified by the City Council below) to Supplemental Environmental Impact Report Nos. 87-1087 and 87-1088, in connection with the Miramar Ranch North Community Plan amendment, on file in the office of the City Clerk, have been completed in compliance with the California Environmental Quality Act of 1970 (California Public Resources Code section 21000 et seq.), as amended, and the State guidelines thereto (California Code of Regulations section 15000 et seq.), that the reports reflect the independent judgment



The other portion of the project, located between Spring Canyon Road and a point approximately 500 feet east of Cypress Canyon Road, would require an additional right-of-way that may be either purchased or the existing road may be realigned to accommodate this road within the existing right-of-way.
