RESOLUTION NUMBER R-281522

ADOPTED ON FEBRUARY 24, 1993

BE IT RESOLVED, by the Council of The City of San Diego, that it is hereby certified that the information contained in Environmental Impact Report DEP No. 91-0830, on file in the office of the City Clerk, has been completed in compliance with the California Environmental Quality Act of 1970, as amended, and the State guidelines thereto (California Code of Regulations section 15000 et seq.), that the report reflects the independent judgment of The City of San Diego as Lead Agency and that the information contained in the Report, together with any comments received during the public review process, has been reviewed and considered by this Council in connection with the consideration of the San Diego River Outfall Project.


BE IT FURTHER RESOLVED, that the City Attorney is directed to return to the Council in thirty (30) days with an amendment to the appropriate section of the San Diego Municipal Code to permit payment of mitigation costs for violations of the Fair Share policy upon findings of adverse environmental or community impacts due to construction of the wastewater system.

BE IT FURTHER RESOLVED, that pursuant to the appropriate Municipal Code amendment referenced above, the Council conceptually authorizes the expenditure of \$5,000,000 from the appropriate special wastewater fund, other than the General Fund,

for the Sunset Cliffs Natural Park project as mitigation for violation of the Fair Share policy; the \$5,000,000 shall be allocated for completion of the Sunset Cliffs Natural Park Master Plan, erosion control, and operation and maintenance of the park.

BE IT FURTHER RESOLVED, that, consistent with the recommendation of pursuing a tunnel connection through Point Loma to the Point Loma Outfall Extension as the environmentally preferred alternative, the City Manager is authorized and directed to take all necessary measures to plan for same.
