BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF SEA WORLD SEWER EXPANSION INFLUENT SEWER REPLACEMENT FOR PUMP STATION NO. 43 in accordance with the specifications.

BE IT FURTHER RESOLVED, that the additional expenditure of \$95,547.00 from Sewer Revenue Fund 41506, CIP 44-001.0, ANNUAL ALLOCATION - SEWER MAIN REPLACEMENTS, to supplement Resolution R-280098 is hereby authorized for the purpose of executing this contract and related costs.
