

RESOLUTION NUMBER R- 281542

ADOPTED ON MAR 01 1993

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE PUBLIC STREETS, HIGHWAYS, AND SERVICE EASEMENTS VACATION LAW, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE DEWEY STREET, BETWEEN MAIN STREET AND NEWTON AVENUE, THE ALLEY IN BLOCK 96 OF MAP 209 AND MAP 379, AND THE ALLEY ADJACENT TO LOTS 20-30, BLOCK 95, OF MAP 209, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the public interest and convenience of said City require the vacation of Dewey Street, between Main Street and Newton Avenue, the alley in Block 96 of Map 209 and Map 379, and the alley adjacent to Lots 20-30, Block 95 of Map 209, hereinafter mentioned.

2. That it is the intention of said Council to order the vacation of Dewey Street, between Main Street and Newton Avenue, the alley in Block 96 of Map 209 and Map 379, and the alley adjacent to Lots 20-30, Block 95 of Map 209, as more particularly shown on Drawings No. 18048-B, No. 18049-B and No. 18059-B on file in the office of the City Clerk as Document No.

RR- 281542.

3. That this Council hereby elects to proceed in making said vacation under the provisions of the "Public Streets, Highways, and Service Easements Vacation Law." California Streets and Highways Code section 8300 et seq.


4. That this Council hereby fixes 10:00 a.m. on

That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in said City of San Diego, be, and it is hereby designated as the newspaper in which the Street Superintendent of said City shall cause to be published, in the manner and form required by law, notice of the passage of this Resolution of Intention, and the Street Superintendent is hereby directed to cause notices of the passage of this resolution to be posted in the manner and form required by law and to cause a notice similar in substance to be published in said newspaper in the manner required by law.
