
ADOPTED ON MAR 01 1993

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a grant deed of PAUL TOM SPARROW and SUSANNE I. SPARROW, executed in favor of The City of San Diego, bearing date of June 4, 1992, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 281544, granting to said City an easement for a public alley in Lots 38 through 42 inclusive, Block 2 of Second Fortuna Park Addition, Map No. 895, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public alley.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.


