A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING TRANSMISSION TO THE COUNTY OF SAN DIEGO OF FUNDS FOR THE COUNTY EDUCATIONAL REVENUE AUGMENTATION FUND.

WHEREAS, State of California (the "State") legislation requires that each redevelopment agency in the State pay a proportionate share of two hundred five million dollars (\$205,000,000) to the County Educational Revenue Augmentation Fund; and

WHEREAS, the State Finance Director has informed each redevelopment agency what their proportionate shared is; and

WHEREAS, the Redevelopment Agency of The City of San Diego's share is two million seven hundred seven thousand five hundred seventy dollars and sixty-five cents (\$2,707,570.65); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby authorizes transmission to the County of San Diego of the Redevelopment Agency of The City of San Diego's proportionate share of funds to be deposited in the County Educational Revenue Augmentation Fund.

BE IT FURTHER RESOLVED, that the funds to be paid into the County Educational Revenue Augmentation Fund shall come from the following redevelopment projects in the following amounts:
