
RESOLUTION NUMBER R- 281553

WHEREAS, in Closed Session on January 12, 1993, the City Council, by the following vote: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, and Mayor Susan Golding, Not Present, District 2, and Vacant, District 8, approved the following; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to pay the total sum of THIRTY FIVE THOUSAND DOLLARS (\$35,000) in the settlement of each and every claim against The City of San Diego, its agents and employees, United States District Court Case No. 91-1075K(P), Lizann Green, et al. v. City of San Diego resulting from the fatal shooting of Walter Andrew Welch.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of THIRTY FIVE THOUSAND DOLLARS (\$35,000), made



payable to LIZANN GREEN, WALTER ANDREW ERIC WELCH, III, and DAVID C. SIEGEL, ESQ. in full settlement of the lawsuit and of all claims.
