
WHEREAS, the San Diego Urban Corps has completed the survey and it is desirable that the information be computerized; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and directed to enter into an agreement with Susan Kinkade, Plant Recorder, to complete a computerized horticultural inventory of Balboa Park.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$4,429.34 from Balboa Park Fund No. 60250 is hereby authorized, solely and exclusively to provide funds for this agreement.

BE IT FURTHER RESOLVED, that the Council hereby commends the San Diego Urban Corps for its accurate and thorough Horticultural Survey of Balboa Park.
