

RESOLUTION NUMBER R-281562

ADOPTED ON MARCH 2, 1993

WHEREAS, the California Government Code sections 65350 to 65362, inclusive, set forth State requirements for the preparation, adoption, and amendment of local general plans; and

WHEREAS, the State law and City Council Policy 600-7 require that consistency be maintained among the City's General Plan and the various community plans and other official planning-related documents, subject to the limitation of frequency of amendments to mandatory elements of the General Plan; and

WHEREAS, the planning actions identified in Item 10 in Manager's Report P-93-004 dated December 22, 1992, a copy of which is on file in the office of the City Clerk as Document No. RR-281311, were approved by the City Council on February 15, 1991, but they do not become effective unless and until the GENERAL PLAN is amended to be consistent with those actions; and

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on October 8, 1992, to consider amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO to reflect the planning actions noted above; and

WHEREAS, the Planning Commission on October 8, 1992, adopted Resolution No. 1003-PC, approving and recommending that the City Council adopt the proposed amendments to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the planning actions for The Mission Bay Park Master Plan and Ocean Beach Precise Plan and Local Coastal Program Addendum


