

RESOLUTION NUMBER R-281569

ADOPTED ON MAY 1 1993

WHEREAS, MERCK & CO., INC., a New Jersey corporation, has requested an exchange of sewer easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the sewer easement to be acquired will serve the same use and purpose as the sewer easement (sewer license) to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of MERCK & CO., INC., executed in favor of The City of San Diego, bearing date of October 15, 1992, conveying to said City a sewer easement in Pueblo Lot 1164, Misc. Map 36, Mannasse and Schiller, Block 50, Map No. 209, and Guymon Industrial Park, Map No. 6297, as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No.


RR-281569-1, is hereby approved.

2. That the City Manager or his designee be, and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-281569-2 quitclaiming to MERCK & CO., INC., all of the City's right, title and interest in the sewer easement (sewer license) in Pueblo Lot 1164, Misc. Map 36, Mannasse and Schiller, Block 50, Map No. 209,

and Guymon Industrial Park, Map No. 6297, as more particularly described in the quitclaim deed.

3. That the City Clerk shall cause both deeds, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder, the easement deed recorded at no fee, for the benefit of the City, with no documentary tax due.
