RESOLUTION NUMBER R- 281575

ADOPTED ON MAR 1 1993

WHEREAS, the Rancho Bernardo Rotary Club Foundation, Inc., has donated five thousand dollars (\$5,000.00) to the Rancho Bernardo Community Foundation for the purchase of a vehicle to be used by the Rancho Bernardo Retired Senior Volunteer Patrol (RSVP), an official volunteer activity of the San Diego Police Department; and

WHEREAS, the Rancho Bernardo Community Foundation has used the donation to purchase a vehicle for the Retired Senior Volunteer Patrol; and

WHEREAS, the vehicle will enhance and support the citizen patrol activities of the Retired Senior Volunteer Patrol; and

WHEREAS, the San Diego Police Department administration has agreed to assume operation and maintenance costs of approximately one thousand two hundred dollars (\$1,200.00) per year over the useful life of the purchased vehicle; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and is hereby, authorized to approve the purchase and use of the vehicle obtained with the funds donated to the Retired Senior Volunteer Patrol.

BE IT FURTHER RESOLVED, that the City Council, on behalf of the City of San Diego and the San Diego Police Department, expresses appreciation to the Rancho Bernardo Rotary Club Foundation, Inc., and the Rancho Bernardo Community Foundation for this donation and assistance, and recognizes the significant

benefit the vehicle will have on the law enforcement and crime prevention activities of the Retired Senior Volunteer Patrol.

BE IT FURTHER RESOLVED, that any liability arising out of the use of this donation or the vehicle purchased by it, including civil court action for damages, shall be the responsibility of the donation recipient and the authorizing agency; the Rancho Bernardo Rotary Club Foundation, Inc., and the Rancho Bernardo Community Foundation, their administrators and affiliates, disclaim responsibility for any such liability.
