WHEREAS, Naval Air Station (NAS) Miramar, as part of the Naval complex in San Diego, acts as a stabilizing influence on the economy, with NAS Miramar providing 15,000 military, civilian and contractor jobs with an overall economic impact greater than \$1 billion; and

WHEREAS, NAS Miramar accommodates the City's critical infrastructure needs by hosting San Diego's only landfill and working with the City on a master plan to extend the life of the landfill well into the next century; and

WHEREAS, NAS Miramar has accepted the relocation of the City's sludge drying facilities from Fiesta Island and the location of aspects of the City's Clean Water Program; and

WHEREAS, NAS Miramar is working with the City on the extension of Nobel Drive and the widening of Kearny Villa Road, Miramar Road and Eastgate Mall onto Air Station property; and

WHEREAS, NAS Miramar has proven itself a good environmental steward of the land by preserving critical habitat and protecting 80% of all the vernal pools remaining in San Diego County; and

WHEREAS, NAS Miramar serves as the centerpiece for the City's Multiple Species Conservation Program; and

WHEREAS, through its aggressive noise abatement and community liaison programs, NAS Miramar has consistently responded to community concerns, with noise complaints

significantly declining over the past eighteen years; and

WHEREAS, since its inception in the early 1900s as Camp
Kearny, NAS Miramar has served with distinction as an important
part of our national defense and its men and women have given the
ultimate sacrifice in defense of our nation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council considers Naval Air Station (NAS) Miramar an important and integral part of the San Diego community and does hereby endorse soliciting support from our State and Federal representatives in retaining NAS Miramar as a defense installation.

BE IT FURTHER RESOLVED, that in recognition of the City's friendship with the air station and as a gesture of thanks, this Council hereby declares the week of August 8 through 14, 1993 to be "NAS MIRAMAR APPRECIATION WEEK" to coincide with the Navy's annual air show.
