BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF MISSION BAY SEWAGE INTERCEPTOR SYSTEM - PHASE V.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,299,700.00, from Sewer Revenue Fund 41506, CIP 46-158.0, is hereby authorized solely and exclusively for providing funds for said project and related costs.
