BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The Council hereby reconfirms the City Manager's Declaration of a Flooding Emergency in the Tijuana River Valley area.

2. The Council hereby authorizes the modification of the Fiscal Year 1993 Capital Improvement Project budget by \$290,000 from Fund No. 30300 (TransNet) to include CIP No. 52.567.0, "Reconstruction of Hollister Street in the Tijuana River Valley."

3. The transfer of \$290,000 from Fund No. 30300 (TransNet) to CIP No. 52-567.0, "Reconstruction of Hollister Street in the Tijuana River Valley" is hereby authorized and approved.


4. The expenditure of an amount not to exceed \$290,000 from CIP No. 52-567.0 (TransNet) is hereby authorized and approved, solely for the purpose of executing the herein described project and related costs.

5. The City Manager is hereby authorized to award a contract to accomplish the reconstruction of Hollister Street in the Tijuana River Valley.

6. The use of City forces for this project is hereby authorized and the San Diego Municipal Code requirements regarding the use of City forces is hereby waived for this project.
