- 5. The City Manager is hereby authorized to award a contract to accomplish the reconstruction of Hollister Street in the Tijuana River Valley.

6. The use of City forces for this project is hereby authorized and the San Diego Municipal Code requirements regarding the use of City forces is hereby waived for this project.
