A RESOLUTION APPROVING AN APPLICATION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT FOR A GRANT FOR THE HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS PROGRAM

WHEREAS, Housing Opportunities for Persons With Aids (HOPWA) is a program sponsored by the U.S. Department of Housing and Urban Development (HUD) which provides resources and incentives for addressing the housing needs of persons with acquired immunodeficiency syndrome (AIDS) and related diseases; and

WHEREAS, the City of San Diego is the eligible applicant for a formula grant of \$1,245,000 for this second round of HOPWA funds; and

WHEREAS, the County Department of Health Services was the eligible applicant and coordinator for the first round of HOPWA funds; and

WHEREAS, the San Diego Housing Commission and the County Department of Health Services have cooperated in pursuing these special housing funds; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. The City Manager is hereby authorized to submit a grant application to HUD for the HOPWA program, the form of which application is on file in the office of the City Clerk as Document No. RR-281614, and to, subject to approval as to form and legality by the City Attorney, execute any necessary

documents related to receipt of awarded funds and program implementation.

BE IT FURTHER RESOLVED, that the San Diego Housing Commission is directed to implement the HOPWA program in cooperation with the County of San Diego, and in accordance with program regulations.
