

RESOLUTION NUMBER R- 281621

ADOPTED ON MAR 16 1993

WHEREAS, The City of San Diego ("City") previously approved a contract with Schmidt Design Group, Inc., and the Southeast Economic Development Corporation ("SEDC"), pursuant to City Council Resolution No. R-277774 on April 23, 1991; and

WHEREAS, all SEDC contracts are being assigned to the Redevelopment Agency of The City of San Diego (the "Agency");
NOW, THEREFORE,

RE IT RESOLVED, by the Council of The City of San Diego, that it hereby assigns all its rights, assets, obligations and liabilities of the contract for consulting services, for a total contract award not to exceed One Hundred Seventy Thousand Three Hundred Forty-Seven Dollars (\$170,347), to the Agency. A copy of the contract is on file in the office of the City Clerk as Document No. RR-277774.


BE IT FURTHER RESOLVED, that the City Council transfer One Thousand Seven Hundred Ninety Dollars (\$1,790) in Capital Outlay funds (Fund #30245) from Project First Class continuing appropriations (CIP #395000) to the Redevelopment Agency Imperial Avenue Median Improvements project (CIP #392520) for the Imperial Avenue portion of the Schmidt Design contract.

BE IT FURTHER RESOLVED, that alternative sources of funding be identified to finance the remaining fifty-two thousand four hundred seventy-four dollars (\$52,474) of the contract, with that amount being broken down as follows: thirty-two thousand three

hundred seventy-four dollars (\$32,374) for the Market Street portion of the Schmidt Design contract, and twenty thousand one hundred dollars (\$20,100) for related SEDC administration.

BE IT FURTHER RESOLVED, that SEDC staff return to the City Council on April 13, 1993, and report on the alternative source(s) of funding identified in the paragraph immediately preceding this one.
