W.O. 112175, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for RECONSTRUCTION OF MIRAMAR ROAD STORM DRAIN.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to establish CIP 11-300.0, RECONSTRUCTION OF MIRAMAR ROAD STORM DRAIN.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$351,000.00 FROM CIP 11-256.0, IVY STREET, GRAPE STREET AND HAWTHORN STREET DRAINS

UNDER RAILROAD TRACKS, Proposition "A" Fund 30300, to CIP 11-300.0, RECONSTRUCTION OF MIRAMAR ROAD STORM DRAIN, proposition "A" Fund 30300; and authorizing the expenditure of \$351,000.00 from CIP 11-300.0, RECONSTRUCTION OF MIRAMAR ROAD STORM DRAIN, Proposition "A" Fund 30300, for the purpose of executing this contract and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, in the project until construction is completed.
