WHEREAS, the Police Department of The City of San Diego has accepted, via Resolution Number R-280184 (adopted on June 22, 1992), a Special Purpose Grant from the United States Department of Housing and Urban Development for five hundred thousand dollars (\$500,000) to develop and implement an innovative augmentation to the Drug Abuse Resistance Education (D.A.R.E.) Program in low-income, public and subsidized housing areas throughout the City; and

WHEREAS, grant funding includes an allocation of one hundred seventeen thousand dollars (\$117,000.00) for a thirty-six (36) foot motor home and necessary modifications, for use as a mobile classroom, equipment storage, transportation, office space, and community focal point for D.A.R.E. WHEREAS, grant funding also includes an allocation of four thousand eight hundred dollars (\$4,800.00) in operating costs for the motor home (two hundred dollars (\$200.00) per month for the grant period of twenty-four (24) months); and

BE IT FURTHER RESOLVED, that any liability arising out of the performance of the Grant Award Agreement, including civil court action for damages, shall be the responsibility of the grant recipient and the authorizing agency; the Federal Government and the Department of Housing and Urban Development disclaim responsibility for any such liability; and BE IT FURTHER RESOLVED, that any grant funds expended hereunder shall not be used to supplant expenditures controlled by this body.
