BOARD OF DIRECTOR ELECTIONS.


BE IT RESOLVED, by the Council of The City of San Diego,

Development Corporations shall hold board elections in accordance
with amended Council Policy No. 700-2 prior to the Council making
any decisions regarding future funding.

RE: Community Development Corporation (CDC) Elections

Proposed wording to be added as paragraph 5 to the Policy section of Council Policy 700-2 as modified by the letter of March 3, 1993 from the Greater Golden Hill Community Development Corporation and accepted by the PS&S Committee at its meeting of 3/3/93.

5. The City occasionally provides "core" assistance to community development corporations to sustain a permanent basic staff capability to identify and advocate for the solution to community issues. The funding is generally used to maintain an office and permanent staff to carry out activities such as publishing a newsletter, identifying and addressing neighborhood issues, conducting community events and acting as an advocate for community empowerment. It is the policy of the Council to require CDCs to open their membership to the residents, businesses, and property owners of the communities served and require the Board to be elected by the membership, as a condition for eligibility to receive core operating support from the City.
