RESOLUTION NUMBER R- 281643

ADOPTED ON MAR 22 1993

WHEREAS, the City of San Diego Police Department, in cooperation with the San Diego County Safety Council, has submitted a proposal entitled "BUCKLE UP SAN DIEGO II" to the California Office of Traffic Safety for seventy five thousand dollars (\$75,000.00) to implement a public education campaign to foster awareness and compliance with the use of child and adult vehicle safety restraints; and

WHEREAS, the San Diego County Safety Council is the local entity qualified to operate such a traffic safety education program; and

WHEREAS, the California Office of Traffic Safety requires that the grant be contracted through a government agency, and therefore, the City of San Diego wishes to sub-contract with the San Diego County Safety Council for grant operations, with the City acting as applicant, fiscal agent, and contractor; and

WHEREAS, there is no requirement for matching funds and City responsibility will consist of administering funds, providing technical assistance, and performing periodic sight surveys of restraint compliance, all of which are not expected to exceed approximately four thousand six hundred dollars (\$4,600.00) in in-kind personnel expenses; and

WHEREAS, the City of San Diego, its citizens and municipal services will realize substantial benefits from the safety education provided by this grant as operated by the San Diego

County Safety Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and is hereby, authorized to submit the Grant Application Proposal, a copy of which is on file in the Office of the City Clerk as Document No. RR- 281643-1, to the California Office of Traffic Safety; and he is further authorized to accept and execute the grant proposal program, including any extensions or amendments thereof, and to act as fiscal agent and contractor.

BE IT FURTHER RESOLVED, that the City Manager be, and is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with the San Diego County Safety Council, to conduct the "Buckle Up San Diego II" program under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 281643-2.

BE IT FURTHER RESOLVED, that the authority of the City Manager shall include providing such administrative and technical assistance and support to the grant program as required by the California Office of Traffic Safety, including all aspects of program operation, expenditures and accounting, under the terms and conditions of the approved grant program proposal.


BE IT FURTHER RESOLVED, that any liability arising out of the performance of the Grant Award Agreement, including civil court action for damages, shall be the responsibility of the grant recipient and the authorizing agency; the State of California and the Office of Traffic Safety disclaim responsibility for any such liability.

BE IT FURTHER RESOLVED, that any grant funds received

hereunder shall not be used to supplant expenditures controlled
by this body.
