BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with the East County Jewish Community Center, for an after-school youth program as part of the Neighborhood Pride and Protection Program, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 281658, as well as any reasonably necessary modifications or amendments thereto which do not increase the above project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of the project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$28,000 from Community Park and Recreation Fund No. 100, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
